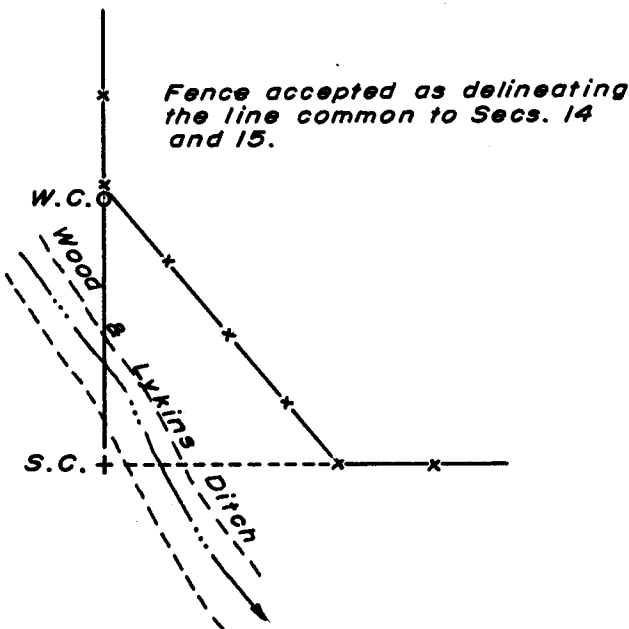
DESCRIPTION OF MONUMENT AND ACCESSORIES ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

At the corner: Corner falls on top of right bank of the Wood & Lykins Ditch, no monument set since ditch cleaning operations would surely destroy any set.

Accessories: A 5/8" dia. x 24" long rebar with Surv KAP bears N 0°04'30" E, on line common to Secs. 14 and 15, 56.0 feet distant.
