

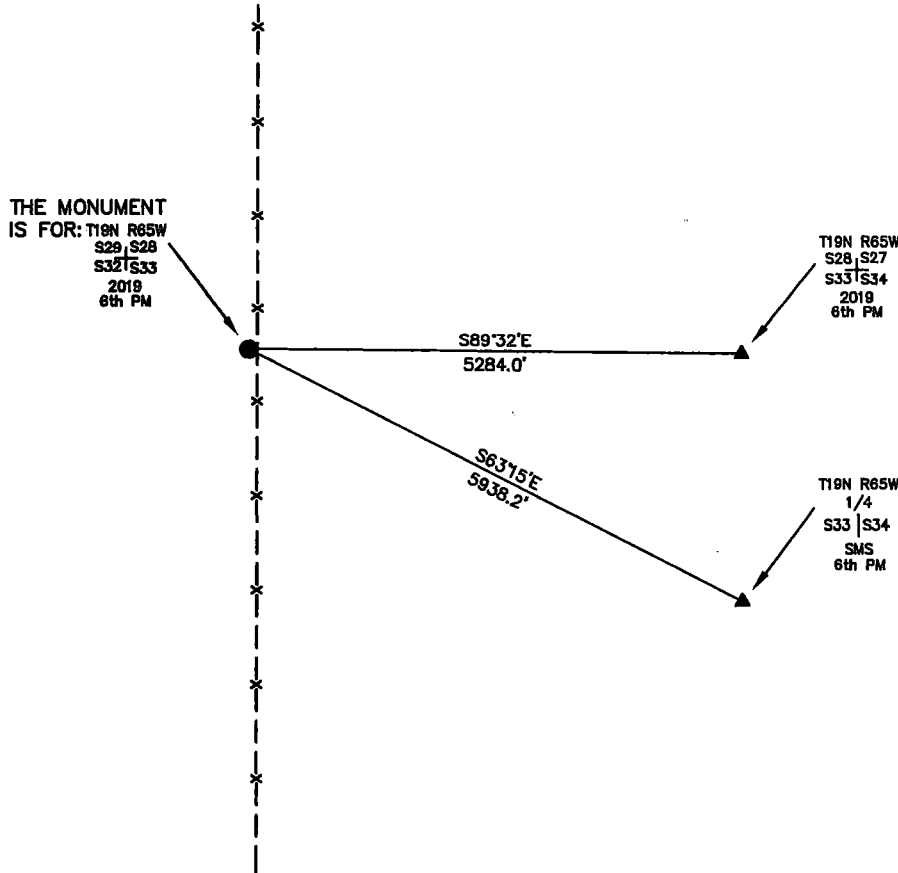

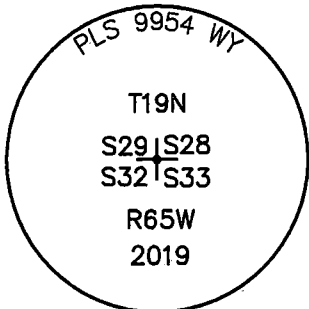

SET THE MONUMENT FOR THIS CORNER COMMON TO 4 SECTIONS WHICH IS A 2019 2.5" PRIVATE ALUMINUM CAP PROTRUDING 0.6' ABOVE THE GROUND ON A #6 REBAR SET IN A NORTH AND SOUTH FENCE LINE USING SINGLE PROPORTION NORTH AND SOUTH BETWEEN THE SOUTHEAST CORNER OF SECTION 32 AND THE EAST 1/4 CORNER OF SECTION 29, PILED STONES AROUND THE MONUMENT.

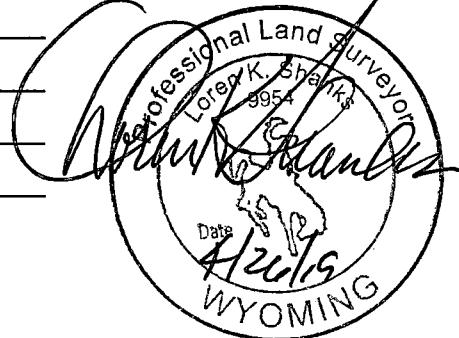
