

# State of Wyoming Corner Record

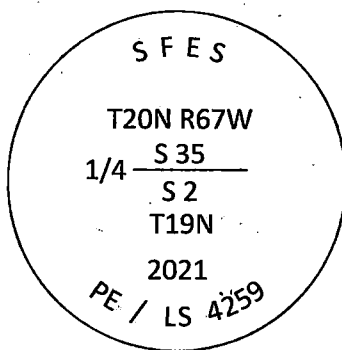

Record of original survey and citation of source of historical information (if corner is lost or obliterated). Description of corner monumentation evidence found and/or monument and accessories established to perpetuate the location of this corner. Sketch of relative location of monument, accessories, and reference points with course and distance to adjacent corner(s) (if determined in this survey).

**Original Record:** (J Wesley Hammond - 8/23/1872) Set a sandstone 18"x10"x3' for 1/4

**Evidence Found:** No evidence of original stone. I observed a jog in the fence line to the south. I asked Charlotte Denny, the property owner, about the jog in the fence and she stated that the remains of a North/South fence terminated at the jog and that was the property line. The jog in the fence is approximately 15' east of the calculated single proportion location.

**Perpetuation:** I accepted the jog in the fence as the best available evidence of the centerline of the Section and set a 2.5" diameter aluminum cap marked as shown below on a 5/8" x 24" reinforcing bar 11" below the surface roughly in the middle of the road for the 1/4 Corner.



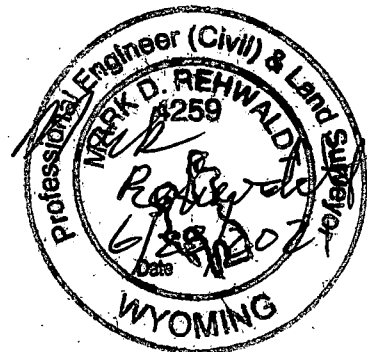
