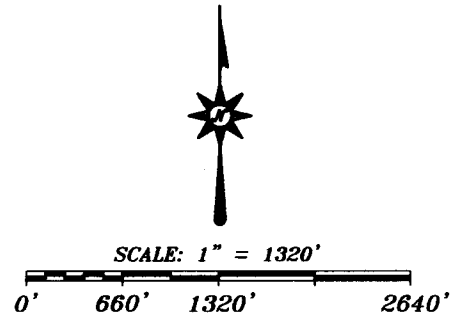
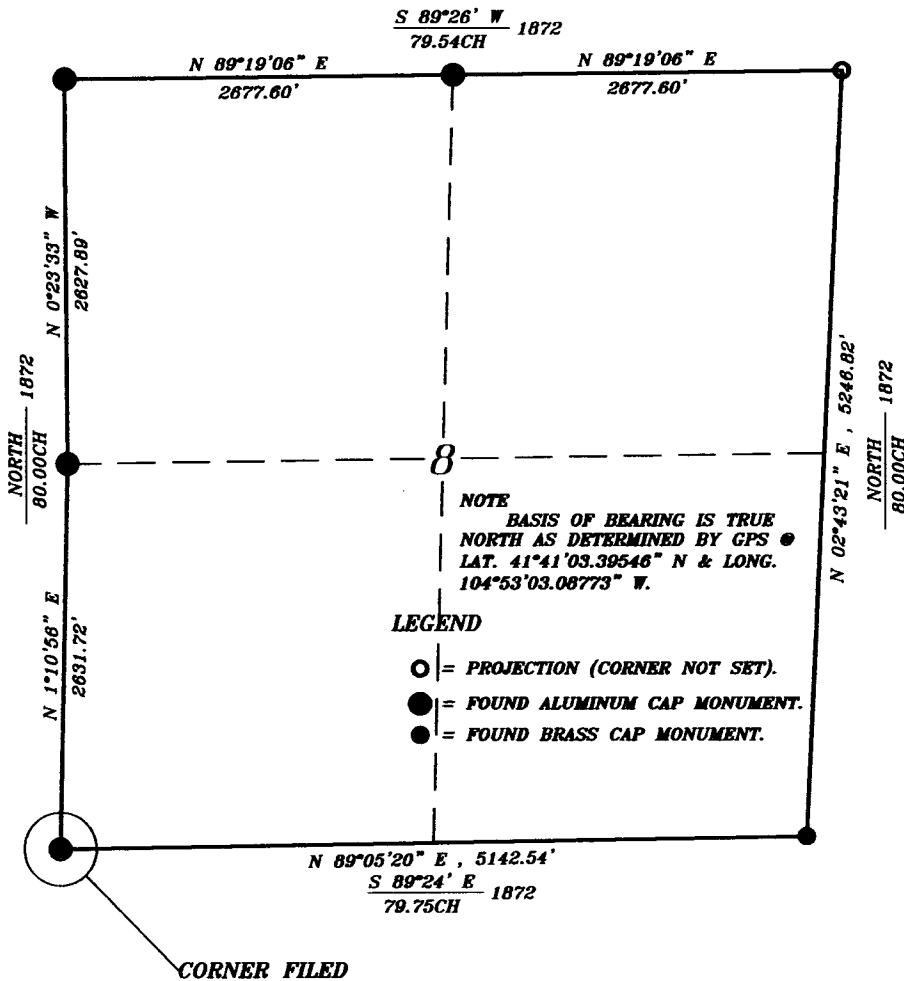


# State of Wyoming Corner Record
