G.L.O. Record: Set a granite boulder 19 x 10 x 8 for corner to sections, 35 & 36, 1 & 2.
Edwin James, U.S. Deputy Surveyor, April, 1871

Found: A loosely set 19" x 8" x 10" granite type stone, marked with 3 notches on the east edge and 3 notches on the west edge, approximately 1' north of a fence corner post of fences extending North and East.

Set: No. 6 x 30" rebar with a marked 3 1/4" domed aluminum cap. Raised a small mound of stone East of the corner. Buried the original stone as a memorial along the west side of the new monument.

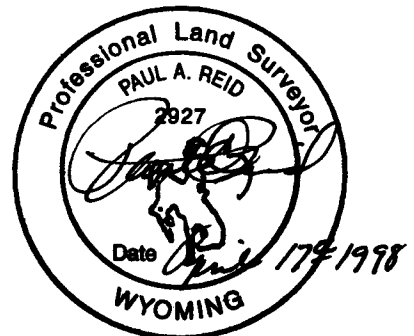
