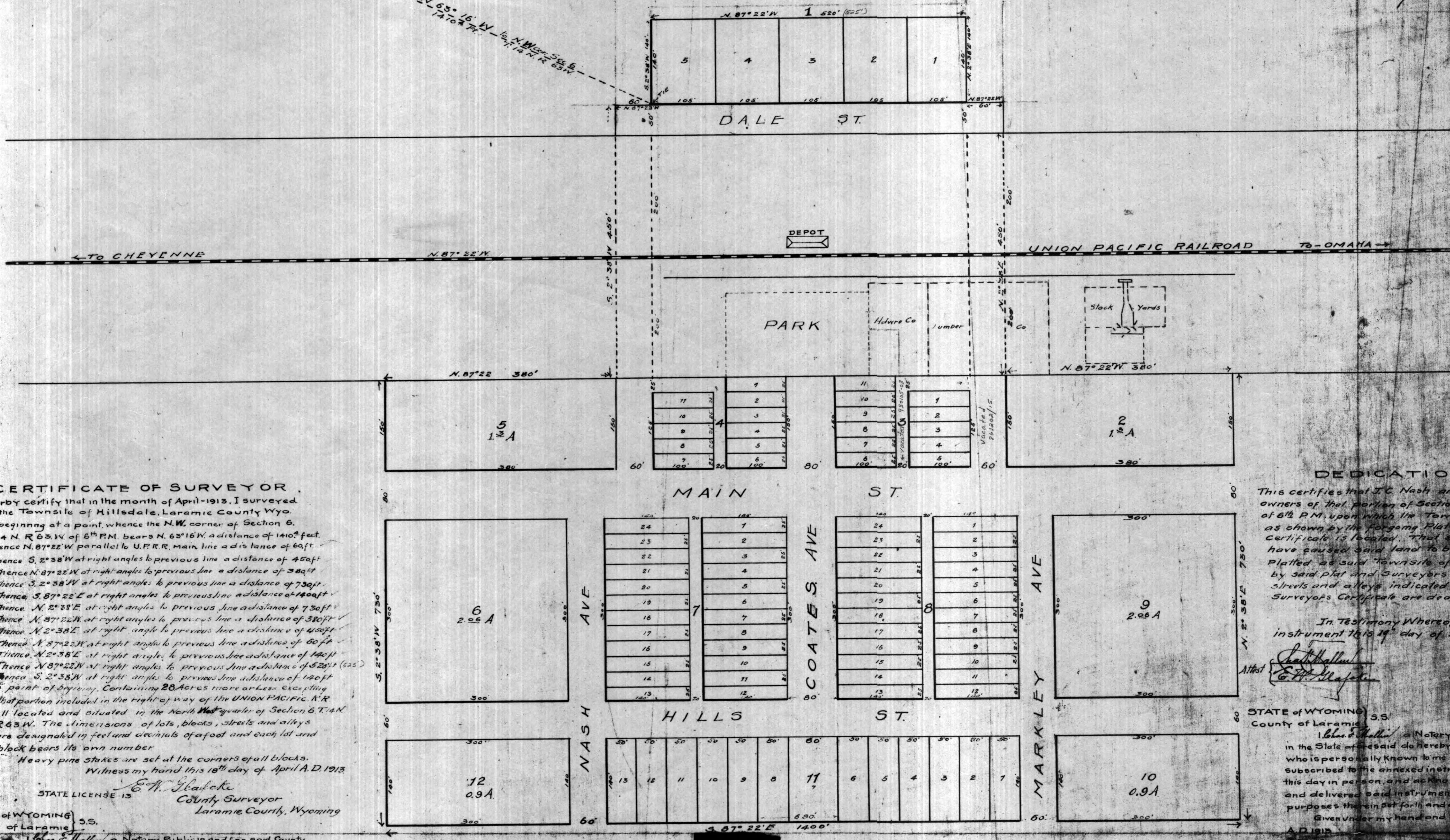

CERTIFICATE OF SURVEYOR

I hereby certify that in the month of April 1913, I surveyed the Township of Hillsdale, Laramie County Wyo. by beginning at a point, whence the N.W. corner of Section 6, T. 14 N. R. 63 W. of 6th P.M. bears N. 63° 16' W. a distance of 1410 feet. Thence N. 87° 22' W. parallel to U.P.R.R. main line a distance of 60 ft. Thence S. 2° 38' W. at right angles to previous line a distance of 450 ft. Thence N. 87° 22' W. at right angles to previous line a distance of 380 ft. Thence S. 2° 38' W. at right angles to previous line a distance of 730 ft. Thence S. 87° 22' E. at right angles to previous line a distance of 1400 ft. Thence N. 2° 38' E. at right angles to previous line a distance of 730 ft. Thence N. 87° 22' W. at right angles to previous line a distance of 380 ft. Thence N. 2° 38' E. at right angles to previous line a distance of 450 ft. Thence N. 87° 22' W. at right angles to previous line a distance of 60 ft.
